

# RETAILER SURVEY COMPETITION (GAME OF SKILL)

## TERMS AND CONDITIONS

---

1. 2. Only residents of Australia aged 18 years of age or older (**Participant**) are eligible for the Competition.
3. The following person(s) are ineligible to enter the Competition:
  - (a) employees of:
    - (i) the Promoter; and

7. The **Participating Precinct** is: King Street
